

Die Verkoop van losbates by wyse van Veilig is onderhewig aan:

1. 'n Reserwe prys, indien van toepassing.
2. Alle voornemende Bieërs moet registreer voor die veiling en vir sodanige registrasie benodig ons u bewys van identiteit en woonadres (FICA) soos gestipuleer in regulasie 26.
3. 'n Terugbetaalbare deposito mag betaalbaar wees in kontant en/of bank gewaarborgde tjek op die dag van die veiling.

10. Goedere wat goegeken is, bly op die risiko van die Koper.
11. Geen aankope mag verwyder word voordat die koopprys betaal is en voor die afloop van die veiling nie.
12. Betalings: **STRENG KAART OF EFT**. Geen kontant betalings word aanvaar.
13. 'n Bod is eksklusief van BTW.
14. Alle verkope is finaal.
15. Koperskommissie van soos vooraf geadverteer en/of afgekondig op dag van veiling word gehef op hoogste bod plus 15% BTW daarop.

The Sale of loose assets by Auction is subject to:

1. A reserve or upset price, if applicable.
2. All prospective bidders must register prior to the auction and such registration requires proof of identity and residence (FICA) as contemplated in regulation 26.
3. A refundable deposit may be payable by cash or bank guaranteed cheque on day of Auction.
4. The Auctioneer may bid for any lot or lots offered for sale at the Auction on behalf of third parties.
5. The auctioneer may bid for any lot or lots offered for sale at the Auction on behalf of seller but, if on behalf of the seller, not at or in excess of the reserve price, if applicable.
6. The Bid will be closed on the highest Bid.
7. The auctioneer has the right to regulate the Bidding. He may furthermore withdraw any item at any time for whatsoever reason.
8. The Auctioneer will not be held responsible for any errors of description. A Bid shall be taken as proof that the Bidder has made himself/herself acquainted with the conditions for lots for which he/she bids.
9. The lot will be sold "voetstoots" and on "AS IS –WHERE IS" condition. It is the Purchaser's responsibility to perform an inspection of the asset prior to the auction.

11. No goods may be removed from the auction site before the last bid has been finalised and payment received therefore.
12. Payment: STRICTLY CARD OR EFT. No cash payments will be accepted.
13. All Bids are exclusive of VAT.
